Standard Collection Notice

1. The Parish collects personal information, including sensitive information, about parishioners and others who use its services. The primary purpose of collecting this information is to enable it to administer the sacraments and pastoral care. Information may be required to allow the Parish to meet some of its legal obligations, provide care for a child while under supervision and discharge its duty of care. If you reside in the Parish or use its services, the information may also be used to solicit donations and/or request your services as a volunteer from time to time.
2. The Parish from time to time discloses personal and sensitive information to others for administrative purposes.
3. If we do not obtain the information requested, we may not be able to administer the sacraments.
4. Personal information collected from children is disclosed to their parents or guardians. Parents or guardians may seek access to personal information collected about them and their children by contacting the Parish Centre.
5. Adults may also seek access to information collected about them in the same manner as above.
6. The Parish will not disclose your personal information to parties outside the Parish or Archdiocese for non-Parish fundraising purposes without your consent.
7. Please carefully check the information and spelling of names and dates as this information is recorded on the Certificate, in the parish register, and notification will have to be sent after the Confirmation to the church of your child's baptism required by Can Law.
